#### 2024/130 Village Maintenance – Trees & Greens

Mowing Regime** following a Tender process before Christmas, proposed by Cllr Tavernor & seconded by Cllr Garrod, a contract with Hartley's had been agreed with Hartley Garden Services after cancellation of the February Meeting; here **RATIFIED** by a unanimous vote. Cllr Tavernor circulated details of the contract.
- **d. Village Sign** the deposit payment was **RATIFIED**; work had started on fabrication of the sign; completion & delivery expected by May; Planning Application pending all necessary information
- **e. Permanent beacon project** payment had been authorized; the order would be confirmed; delivery expected within two three weeks; work party to be convened for installation

Cllr Williams reported that the pump on Lower Green was in need of maintenance/renovation; having last been refurbished at the Millennium and since given a coat of paint by a generous anonymous benefactor, whose efforts were noted by Council and recorded with gratitude. She also reminded Council of the weeds in the grit boxes. Cllr Kearney informed the meeting of a parishioner who usually kept the grit boxes free of weeds **ACTION** — Cllr Kearney to contact parishioner in question
