2024/062 Chairman's Welcome; to receive apologies for absence — Deputy Chairman Cllr Sparkes welcomed everyone to the meeting and received apologies from Cllrs Williams and Stringer. Chairman Cllr Garrod had sent notice that he would arrive by 20.00hrs

2024/064 Minutes of the Previous Parish Council – the Minutes of the meeting of 10th September were considered, **APPROVED**, and signed by Cllr Sparkes as a true record

2024/065 To receive reports from SCC & MSDC Cllrs

a. SCC Cllr Penny Otton

Cllr Otton's report, previously circulated, was noted and is available on this website. Cllr Otton highlighted forthcoming changes to waste disposal and collection, which would impact County and District Councils respectively; the uncertainty over the future both of Thurston Community College and the proposals for devolution in Suffolk. She also mentioned the interest free loans available for energy efficiency measures and the local Nature Recovery Strategy webinars

b. MSDC Cllr Nicky Willshere

Cllr Willshere had sent her report prior to the meeting and is available on this website. Cllr Wilshere highlighted the lengthy debate in Full Council on controvertial changes to waste collection & recycling, and some of the challenges envisaged, including the future of community (fund raising) bottle banks. New electric vehicles will be purchased. Cllr Willshere also reported on her recent meeting with the Locallity Officer; as well as on possible resources available for improvements to parking facilities on Council owned property. Cllr Sparkes requested that Cllr Willshere investigate the vegetation overgrowth hindering access to the former Community Room(of the formerly sheltered housing) on The Orchard.

2024/066 Public Forum – The Architect for new Application DC/24/04315 Land Rear Of The Six Bells, Church Road, Felsham, spoke of the plans and answered questions from parishioners. He acknowledged parishioners' concerns on this latest, as well as the previous schemes devised by others; the previous scheme still in the process of an Appeal application. He left hard copies of the plans to help the Parish Council its deliberations. Parishioners spoke of the similarities in with previous applications for the site and reiterated the fundamental objections to the scheme: the impact on the core of the settlement within the Conservation Area and inevitable consequential loss of Setting and Amenity; one of the reasons for the refusal to the last Application. Cllr Otton expressed her dismay that SCC Highways had not objected to previous versions of the proposals over access and road safety.
