The Parish Council Meeting minutes of 20th December 2016 were signed as a true record. 2016/1741 **Adjournment for:** County & District Cllr Penny Otton's Report – Cllr Otton gave her report which has been circulated and will be attached to these minutes. **Public Participation** – None **Meeting resumed:** 2016/1742 Clerks Report – It was noted that SCC Highways officer, David Irvin has made a site inspection of Upper Green following the safety concerns raised by a resident. Mr Irvin confirmed that he feels there is no safety issue at this time at the junction with Cockfield Road. The only improvement he can suggest is to lower the height of the hedges at each junction which would improve visibility, as there is no encroachment onto the highway this is not something he can enforce and he also commented that if visibility is improved this may well result in vehicles travelling faster. Mr Irvin also commented on the request for action to improve safety on Cockfield Road adjacent to the properties around Rookery Farm. He confirmed that although there is some erosion of the verges this is common throughout the county and not something he can address. A further accident recently was highlighted and it was agreed that if Cllr Otton were to support with her Travel Budget a vehicle survey could be actioned which will provide evidence of any speeding and form the basis of any request for a speed restriction. The clerk will contact BT to report the safety issue of a pole too close to the highway. The dates for the Suffolk Police Liaison meetings are confirmed as 21st Feb and 8th March 2016/1743 **Planning** – It was resolved to send the following comments to MSDC Planning; Application 5002/16 Removal of four trees as shown in the attached sketch plan and photos: 1. 2016/1751	It was noted that Cllr Otton offered help from her Locality Budget towards the Street Light project. An application for £642 will be completed.
2016/1752	Community Speed Watch – It was agreed that a quarter share, at £350, in the new Speed Gun purchased by Beyton Parish Council was not financially possible at this time. It was agreed that the suggestion to take over the old gun and try to extend its life span would be taken up. If the gun proves serviceable then consideration of the purchase of two signs would be needed.
2016/1753	Village Sign – It was agreed that the project to provide a Village Sign should be progressed by the parish council. Local artists will be asked to bring forward designs for consideration before quotes are sought.
