Village Sign - Chris Bassett confirmed that quotes for the laser cut and frame and post 2019/2750 work are still awaited. The laser cutter had requested the artwork in an alternative format

and sincere thanks were extended to Janey Crick for her time and expertise in

reformatting the design for us.

Discussion took place around the size required for the finished sign and it was suggested that a full scale timber mock up be created in order to test for size in situ. Further

discussion on positioning of the sign took place with Upper Green and the Greensward considered again. It was agreed that a second price be sought from the blacksmith for a

double sided name board in case the final position decided was Upper Green.
